# VI. Reports

**1.Township Manager's Report.** The Manager has submitted updates to the Board of Commissioners on a regular basis from the last meeting.

The Township application to the PA Commission on Crime and Delinquency for Body Worn Camera Use and Policy Development has been recommended for funding by PCCD staff and the Criminal Justice Advisory Committee.

# VII. Elected Officials' Report

Paula Winne advised the residents that the Per Capita Tax is now being collected by Berkheimer Associates. If anyone has questions those should be directed to the School District or to Berkheimer.

Ron Churchin had concerns about the political signs. He recognized there is a limit to what one may do on public property but is there anything able to be done about political signs and the use of profanity.

Solicitor Garen Fedeles reminded the resident of the right to free speech even though it may be considered offensive and the 1<sup>st</sup> Amendment.

Jack Bedalota made inquiry about the recycling center and some of the other properties on Duss Avenue.

Fernando Bevilacqua stated that 1.5 to 2 years ago he had made a donation to the Police Department for body cameras and whether the cameras were being used by the Department. It was referenced that the camera technology had changed and there was a need to establish policies and protocols for the use of the cameras. Mr Bevilacqua indicated that he realized that technology changes and he was curious about the equipment usage.

Marcia Lehman spoke to the need to consider changes to the township ordinance for fracking and oil drilling. She also introduced Terri Baumgarten from Aliquippa who is on the Clean Air Council.

Rosemary Shrum made inquiry as to the status of the Oak Alley situation the Ambridge Regional Industrial Park wanted the Township to vacate. Manager Villella indicated that the vacating of the alley would not benefit all the property owners that still rely upon the road for access to and from their businesses.

Mrs. Kotula voiced concern over the status of Forest Rd and its condition. President DeBona asked Manager Villela to speak, and he advised Mrs. Kotula the Township has been engaged in storm sewer work on the roadway and will review the road and its condition in relation to other roads in the township in need of restoration.
