2) A Motion to authorize the 2024 Budget Adoption Resolution 2023-12-06-01, establishing the revenue neutral rate of real estate tax for the 2024 year which would include general and debt service purposes.

Harmony Township along with all other taxing bodies in Beaver County are required to reset the 2024 millage rate so that the total amount of taxes levied for that year against the real properties does not exceed the total amount it levied on the properties in the preceding year of 2023. Harmony Township has determined that the millage rate to be 4.396 mills.

To comply with 53 Pa. C.S.A. §8823(b), the tax is hereby levied on all real property within the Township subject to taxation for the year 2024 until otherwise amended by the Board of Commissioners:

The Tax Rate total shall be 4.396 mills or \$4.396 dollars on each thousand dollars of assessed valuation. For general purposes, the sum of 3.664 mills on each dollar of assessed valuation, and for debt purposes the sum of .7326 mills on each dollar of assessed valuation.

All other taxes and fees imposed pursuant to the Local Tax Enabling Act and other applicable codes by ordinance AND Resolution will remain in full force and effect. The Budget will be advertised and made available for public inspection at the Municipal Building.

That any ordinance, or part of ordinance, or resolution conflicting with this resolution be the same is hereby repealed insofar as the same affects this resolution.

3) A Motion authorizing the Township Manager to advertise an Ordinance for the adoption of the real estate millage for the 2024 tax year. Harmony Township along with all other taxing bodies in Beaver County are required to reset the 2024 millage rate so that the total amount of taxes levied for that year against the real properties does not exceed the total amount it levied on the properties in the preceding year of 2023. The Township has done so by adopting Resolution 2023-12-06-01.

The Township under 53 Pa C.C.A.§8823© may establish by a separate vote a final tax rate for 2024 not more than 10% greater than the total amount it levied on the properties the preceding year.

That a tax is hereby levied on all real property within the Township subject to taxation for the year 2024 and any years as follows until otherwise amended by the Board of Commissioners:

The total rate of tax shall be the sum of 4.836 mills on each dollar of assessed valuation, or the sum of 4.836 dollars on each one thousand dollars assessed valuation.

For general purposes, the sum of 4.030 mills on each dollar assessed valuation, and for debt purposes the sum of .806 mills on each dollar assessed valuation.

All other taxes and fees imposed pursuant to the Local Tax Enabling Act and other applicable codes by Ordinance and Resolution will remain in full force and effect. The Budget will be advertised and made available for public inspection at the Municipal Building.

That any ordinance, or part of ordinance, or resolution conflicting with this resolution be and the same is hereby repealed insofar as the same affects this Ordinance.
