### Fabiola Gergerich

- 1. Questioned when there would be an update on the Road Projects Plan. President Barlamas explained that discussions have begun regarding the spreadsheet for the Road Projects. Discussions with the Engineer's have started. Also, the Township has received a grant for \$750,00.00 which is a huge plus for the Township. Preliminary plans have started and hopefully a rough draft will be available at the end of January 2025.
- 2. Questioned if the Township received any unused ARPA money. President Barlamas said that by December that information should be available.
- 3. Questioned the new contract with Valley Waste. The new contract is a continuation of the present contract. Harmony Township has an extremely good rate regarding waste removal.
- 4. Questioned the status of the drain. President Barlamas said that the Township has the bottom portion and that Mike Thomas is in pursuit of finding the top portion.
- 5. Question what is the status regarding the number of Police Officers employed by Harmony Township. President Barlamas stated that Harmony Township presently has five (5) Full time Officers and technically (2) part time Officers which are still on the books but are full time for other Townships. However, the new part time Officer will hopefully not be full time for other Townships.
