VI. REPORTS

A. Township Manager's Report:

- 1. LSA Bids are to be opened on May 22, 2025, for the Grant Paving and Storm Sewer Project.
- 2. CSA bids approving the change of scope including Harmony Avenue. This is an ARPA COVID PA Small Water & Sewer Project. This has been included in the bid specs as an alternate.
- 3. Please take a support letter and send the letter to Secretary Seger the Department of Community & Economic Development in support of the Tennis Court Project.
- 4. Grass clippings should not be placed on or in storm sewers, catch basins or blown onto the street. This is against the DEP/MS4 Policy.
- 5. Happy Memorial Day to everyone and thank you to all who have served and their families.

B. Consulting Engineer's Report:

- 1. HRG Engineers submitted last month an application for the Storm Water Improvement Plan for Spruce Street.
- 2. HRG is working on the application for the Tennis Court. Now that the Resolution has been approved, the application will be submitted prior to the June meeting.

- 3. LSA Bids will be opened tomorrow, May 22, 2025. HRG will give their recommendations at the June meeting.
- 4. The Township has applied for funding through RCAP. The application was submitted for a total of 6 million dollars. Three million from the State Project would include park improvements for Beaver, Valley and Byersdale Road Parks. The Township has 10 years to use this money. Also, the Township Manager mentioned that the Township has received a \$5,000.00 dollar donation from the Ambridge Regional Industrial Park for the Harmony Township Master Park Plan. Christine Whipple asked for clarification of the grant. Both the Engineer and the Township Manager explained that this is basically a pool of money that Townships can apply for park improvement projects. The Grant is a matching a grant and the Township applied for 3 million dollars because each park on the Township's Park Master Plan will cost at least 1 million each.
- C. Solicitor's Report. The Solicitor has entered their invoice for services and set forth Forth the work performed for the month of April/May 2025. The Solicitor added to the minutes that an Executive Session was held on May 12th, 2025 with the Board and an employment attorned regarding a potential engagement matter.

VIII. ELECTED OFFICIALS' REPORT

- 1. Commissioner Debona mentioned that summer will be here soon and that lawncare is a necessity. She has noticed that some properties have been neglecting their lawns, and she suggested that the Code Enforcement Officer needs to be aware of this situation.
- 2. Commissioner Molchen mentioned that there will be an Octoberfest event on September 13th, 2025, to benefit the Fire Department. The event is being held at the Fire Hall. There will be beer and wine for sale. A polka band, food trucks and craft vendors will also be there to entertain the public.
- 3. Commissioner Angus congratulated Commissioner Molchen on his win to retain his seat of the Board of Commissioners. Also, congratulations to the new Tax Collector Kelly Harshman. He also wished everyone a Happy Memorial Day.
- 4. Police Chief Villagomez mentioned that the Police Department has a box for residents to dispose of their expired prescription medications.

Kevin Rice

Had a question regarding walking animals in the field portion of Byersdale Park. In the past he has always been permitted to walk his dogs in the field area of the park. There is a posting of no animals permitted in the playground area. However, a few days ago he was stopped by a Police Officer who informed him that he no longer can walk his dogs in the field area of the park. Chief Villagomez said that he would look into this situation.

Christine Whipple

She inquired if there was an update on the paving projects. Is there a timeline for these projects. Commissioner Angus explained that the paving project bids will be opened on June 22nd, 2025. She asked about the grant that the Township received last year for paving project. The Manager explained that the bids are being offered in response to the grant. Once the bids are opened the Engineers will make their recommendations to the Board. The Board can ratify their recommendations at any Board Meeting.

Fabiola Gergerich

She asked for an update on the paving projects. Which streets are involved. The streets involved are Solar, Forest, Woodside, 5th Street, Harmony, Logan Lane and all the roads attached to the Columbia Gas Project. Mrs. Gergerich asked if there would still be a written timeline available for the residents to see. The Township Manager explained that he is working with Mike Thomas, Township Public Works Forman on a street's spreadsheet for residents.

Angela Meyers

She was confused regarding the Building Renovation Project. She thought that the project was already approved. Also, she suggested that the Township's website address be placed on the marquee outside so residents can utilize the website for information. She also wanted to thank the Road Dept. for all their hard work addressing road incidents that have occurred due to bad weather.
