The Township of Harmony/ Harmony Township Municipal Authority has adopted an internal grievance Procedure providing for the prompt and equitable resolution of complaints alleging any action prohibited by Section 04 of the Rehabilitation Act of 1973 (29 U.S.C.794) of the U.S. Department of Health and Human Services regulations implementing the Act. Section 504 prohibits disability in any program or activity receiving Federal financial assistance. The Law and regulations may be examined in the office of Robert Villella, Township Manager, 724-266-1910 who has been designated to coordinate the efforts of Harmony Township Municipal Authority to comply with Section 504.

Any person who believes she or he has been subjected to discrimination on the basis of disability may file a grievance under this procedure. It is against the law for Harmony Township/Harmony Township Municipal Authority to retaliate against anyone who files a grievance or cooperates in the investigation of a grievance.

IV. REPORTS

A. Township Manager's Report:

The Manager has submitted updates to the Board of Commissioners on a regular basis from the last meeting.

- 1. The Manager plans to talk to Department heads regarding the removal of dead trees that have fallen on roadways. This discussion will discuss what type of action will be taken regarding Code Enforcement advising individuals who trees appear to be dead and close to a roadway. These trees should be removed by these individuals especially if these trees knock down wires or other public utilities.
- 2. The Planning Commission has put together some procedures and different types of applications to be submitted. The Commission has been in contact with the Beaver County Planning Commission, specifically Dan Distler, regarding the possibility of Mr. Distler attending future Board Meetings so that the Commission can get in sync with the Beaver County Planning Commission. Also, the Commission has been discussing the possibility of exploring some grants and pro-bono engineering work for grant work, especially in the Commercial Industrial area. The Planning Commission should be recognized for being the only local Commission that has reached out to the Beaver County Planning Commission to work with them and to make sure that the procedures they are following are consistent with the Beaver County Planning Commission.

B. Consulting Engineer's Report:

- 1. The Grant was submitted for the Byersdale Tennis Court last month in the amount of \$350,000.
- 2. HRG is working on a multi road grant application for Valley Road. This application is currently in process.
- 3. Since the Board has approved the motion for the paving. The paving contract will be awarded to Youngblood Paving. After all the required paperwork has been submitted HRG will reach out to Youngblood paving to schedule the work. Christine Whipple had a question for the /Engineer regarding the paving of Virginia Avenue. The Engineer clarified that Lower Virginia is included in this project. Upper Virginia is included in the future work which is coordinated with Columbia Gas.
- C. <u>Solicitor's Report.</u> The Solicitor has entered their invoice for services and set forth Forth the work is performed for the month of May/June 2025. The Solicitor had no further comments.

VIII. ELECTED OFFICIALS' REPORT

Angela Meyers

Question was regarding the removal of dead trees. Does the Township have any help for individuals who cannot afford the hiring of a professional tree service to remove these trees? Can the residents offer their assistance to these homeowners who cannot afford the removal? The Township Manager explained that the fallen trees are being removed by the Public Works Department. Also, any trees which touch or invade any power lines can be removed by Duquesne Light. However, the Township unfortunately does not have the resources to financially help these homeowners. The Manager will contact a few agencies which have helped in the past; but tree removal is dangerous, and the liability is very high if an individual get injured helping out with the tree removal.

Fabiola Gergerich

Mrs. Gergerich is concerned with the roll of AI affecting Harmony Township. For example, she is opposed to surveillance camera use on the roads. Does the Township have any safeguards in place for the invasive use of AI? Also, what type of protection does the Harmony Township residents have if an aggressive mob was to invade the Township? What do the residents have to protect and defend themselves? However, on a lighter note, are there plans to have an open house for the residents to the new Police Department and the Public Works Building? President Barlamas answered the AI question. Since she comes from a banking background, she knows there are tremendous concerns regarding AI. The Township will navigate this problem slowly. One way to combat this problem is to talk to people in person. Also, there will be an open house for residents to tour the new Police Department and the Public Works Building but probably not until fall. The Solicitor answered Mrs. Gergerich question regarding protection from invasive mobs. Beaver County notifies municipalities when they know that there is going to be a potential aggressive meeting or gathering in their area. Local, State and ESU Units are sent in if necessary to deflate the situation.

Regarding the tree issue. Is there a regulation regarding tree branches that grow out into the roadways which can be potentially hazardous? The Solicitor explained that it is the responsibility of the homeowner to maintain their trees. If you are aware of branches invading roadways, please call the Township and the Public Works Department will be notified of the situation.

ADDITIONAL AGENDA ITEM:

The Township Manager and the Police Chief, Juan Villagomez, have been talking to representatives of AT&T and First Net for the purchase of Cameras & internet service (military grade) for the approximate cost of \$11,000.00. These cameras would be placed in every park in Harmony Township including School Street. The

camera feeds will go directly to Chief Villagomez's office. The Manager apologized for the oversight of not having this item on the agenda. But hope that the Board will take into consideration adding this motion especially since the cost could increase due to the end of the quarter.

The Board President called for a motion to add to the agenda the placement of cameras in the Harmony Township parks at the approximate cost of \$11,000.00.
